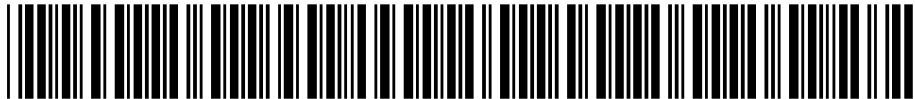

This RELEASE OF COLLATERAL ASSIGNMENT OF LOAN AND LOAN DOCUMENTS is made effective as of September 30 2021, by PACIFIC WESTERN BANK, a California state-chartered bank (the "Agent").

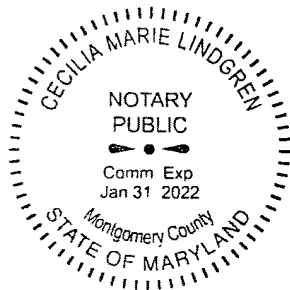


