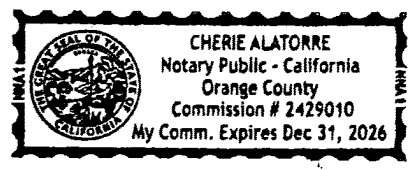

A CONDOMINIUM COMPRISED OF:

PARCEL 1:

AN UNDIVIDED 1/21ST INTEREST IN AND TO THAT PORTION OF LOT 1 OF TRACT NO. 14858, IN THE CITY OF ORANGE, COUNTY OF ORANGE, STATE OF CALIFORNIA, AS SHOWN ON A MAP RECORDED IN BOOK 719, PAGES 31 AND 32 MISCELLANEOUS MAPS, RECORDS OF ORANGE COUNTY, CALIFORNIA, DESCRIBED ON THE CONDOMINIUM PLAN RECORDED MAY 2, 1996 AS INSTRUMENT NO. 19960221164 (THE "CONDOMINIUM PLAN") AS THE CONDOMINIUM COMMON AREA OF MODULE K.

EXCEPTING UNTO GRANTOR, ITS SUCCESSORS AND ASSIGNS, TOGETHER WITH THE RIGHT TO GRANT AND TRANSFER ALL OR A PORTION OF THE SAME:

A. EXCEPT AS GRANTED HEREBY, EASEMENTS AND RIGHTS AS RESERVED TO GRANTOR AS DECLARANT AND OWNER IN THE DECLARATION, INCLUDING, WITHOUT LIMITATION, THE RESERVATION OF OIL, GAS AND MINERAL RIGHTS AND EASEMENTS FOR A COMMUNITY ANTENNA TELEVISION SYSTEM AND FOR CONSTRUCTION, DISPLAY, MAINTENANCE, SALES AND EXHIBIT PURPOSES. AS PROVIDED IN THE DECLARATION, THE RESERVATION FOR OIL, GAS AND MINERAL RIGHTS SHALL NOT RESERVE FOR THE BENEFIT OF THE EXERCISE OF SUCH RIGHTS;

B. EXCEPT AS GRANTED HEREBY, EXCLUSIVE USE COMMON AREA EASEMENTS FOR PARKING SPACES AND FOR INTERNAL AND EXTERNAL TELEPHONE WIRING OVER THAT PORTION OF THE COMMON AREA DESCRIBED ON THE CONDOMINIUM PLAN.
